Subject:- Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations.

Whereas, the Ordinance No.6 and Ordinance No.18/2001 are in existence in respect of providing facilities and concessions for physically disabled students.

And

Whereas, the Government of Maharashtra, Department of Higher and Technical Education had issued G.R. dated 4th of March, 2017 in respect of facilities exemptions for physically disabled students.

And

Whereas, the Management Council in its meeting held on 2.6.2018 vide item No.86 has accepted the afore mentioned G.R. along with the report of committee appointed by Hon'ble Vice-Chancellor and directed to issue direction in this regard,

And

Whereas, the above said provisions are to be regularized by amending respective ordinances,

And

Whereas, aforesaid provisions are to be implemented from the Academic session 2018-19.

And

Whereas, making amendments to concerned ordinance is time consuming process ,

Now, therefore I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby direct as under-

- 1) This direction may be called, **"Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations."**
- 2) This direction shall come into force from the date of its issuance.
- 3) The following shall be the provisions for providing facilities, exemptions, concession for physically disabled students.
 - i) Principal of the respective affiliated college should prepare 'Disabled friends group' of minimum 10 friends out of which disabled students will select one of them who is willing to act as a writer for him/her. He can also select writer of his/her own choice.
 - ii) Examination centre will be the same college or nearer college to his/her house.
 - iii) Answer Books will be stamped as PWD and the necessary separate arrangements be made for evaluation.
 - iv) Differently abled students of all categories will be given additional 20 minutes per hour. besides the stipulated time span.
 - v) Marks should not be deducted for any types of grammatical or technical mistakes at the time of evaluation.
 - vi) Attendance is not mandatory for appearing in the university examinations.
 - vii) All other facilities are applicable as per this direction and guidelines given in the Maharashtra Government Resolution miscellaneous no.2016 No.302 dated 4th of March, 2017.
 - viii) This direction provides 3% grace marks of the total marks (aggregate) in one subject for "Head passing written examination, oral /viva, practical, research project etc." or by divisions to the rest of the followings heads.
 - a) Fixed the 3% marks of the total (aggregate).
 - b) Add marks to the subject with least or minimum marks obtained, first and thereafter, second, Third, fourth and so on to the subjects in order of lower marks till the 3% of marks.
 - c) If needed, the marks as per the earlier ordinances (1/1985 and 18/2001) shall be awarded to the disabled candidates.

Subject : Continuation to the issuance effect of Direction No. 33 of 2017 dated-3.8.2017 which is issued in respect of Prescribing the Revised Examination fees and all its related fees, Direction 2018.

Whereas the fees to be charged from the candidates for examinations with its related fees are to be charged as are prescribed under Ordinance No. 12 "University Fees".

And

Whereas the Management Council in exercise of powers vested in it U/S 28(v) of Maharashtra Universities Act, 1994 on the recommendations of the Academic Council has resolved to revise the said fees for every examination and its other related fees at the rate of 10% after the interval of every three years and since the Direction No 9./2014 i.e. inclusive from Winter 2014 examination, the period of three years is completed till Summer- 2017 Examination.

And

Whereas the matter of prescribing the said revised fees is to be regulated by Ordinance No. 12, and its amendment may take time and fees for Winter 2017 examinations are to be paid by the candidates alongwith examination application forms.

And

Whereas in view of exceptional circumstances existed and for avoiding the administrative complications, it is necessary to continue the issuance effect of Direction No. 33/2017 which is issued in respect of continuation to prescribed the examination fees and its related fees of the University as perscribed by the Maharashtra Public Universities Act, 2016.

Now, therefore, I, Dr. Murlidhar Chandekar, Vice- Chancellor of Sant Gadge Baba Amravati University, in exercise of powers conferred upon me, under sub-section (8) of section 12 of the Maharashtra Public Universities Act, 2016 having issued the following direction.

- (1) This Direction shall be known as "Continuation to the issuance effect of Direction No. 33 of 2017 dated-3.8.2017 which is issued in respect of Prescribing the Revised Examination fees and all its related fees, Direction 2018.
- (2) This Direction shall come into force from the date of its issuance.
- (3) The issuance effect of the Direction No. 33 of 2017 dated-3.8.2017 which is issued in respect of prescribing the examination fees and all its related fees of the University shall be continue upto its approval and final recommendation and passing by concerned authority along with related statutory forms.

1. GENERAL INSTRUCTIONS TO THE CANDIDATES

- (i) Candidates must carefully read the Rule 1/2017 and Ph.D. Ordinance 1/2016 before filling online application form of PET - 2017
- (ii) Candidate will have to pay Rs. 1000/- for Open Category and Rs. 650/- for Reserved Category (SC/ST/DT/NT/OBC) through the payment modes provided in the application form.
- (iii) Candidates belonging to Physically Handicapped category are exempted from the payment of fees. Please refer to Para 34 of the Ordinance No. 6, Clause b) of Ordinance No. 13 of 2001 and Ordinance No. 2 of 2010 of the University for the physically handicapped
- (iv) No Revaluation and Redressal permitted for PET Answer Scripts
- (v) The size of the most recent photograph of the candidate should be restricted to 3.5 cm Width and 4.5 cm Height and the scanned copy in JPG file format should not exceed 50 KB.
- (vi) The size of the signature of the candidate should be restricted to 3.5 cm Width and 1.5 cm Height and the scanned copy in JPG file format should not exceed 10 KB.
- (vii) Candidate is required to upload scanned copy of the following original certificates/documents in JPG file format
 - a. P.G. Marksheet
 - b. P.G. Degree Certificate
 - c. Caste Certificate (wherever applicable)
 - d. Caste Validity Certificate (wherever applicable)
 - e. Non Creamy Layer Certificate (wherever applicable)

2. COURSE CONTENTS OF EXAMINATION

Question paper: The examination will consist of only Objective type (multiple choice) questions requiring candidates to Mouse-click their correct choice of alternatives against the related question number. The candidate can change his selected option at any time during the period of the examination, but the option selected last will be considered for evaluation.

The PET will comprise One Paper with **two** sections, i.e. **Section A & Section B**.

a) Section A – GENERAL APTITUDE Section A will be based on General Aptitude and will be common to all candidates. Test for this Section will be of 50 multiple choice objective questions with 100 marks. Each question will carry two marks. The medium for Section A will be in English and Marathi.

b) Paper Course :

Course of Section A will contain Logical Reasoning, Numerical Ability, Reasoning and Language Aptitude, Aptitude Test, General information on Environment that a common man should know, candidate's awareness of scientific and quantitative reasoning aptitude, analytical approach etc. Questions would be so designed to judge the creativity, analytical ability, reasoning ability, comprehension, divergent thinking, general awareness and research aptitude of a candidate, common elementary computer science, few questions dealing with basic computer awareness and uses.

c) Section B – SUBJECT SPECIFIC Section B will be based on specific subject in the relevant faculty. Test for this Section will be of 50 multiple choice objective questions with 100 marks. Each question will carry two marks. The medium for Section B will be in English and Marathi.

d) Paper Course:

The Paper Course for Section B shall be as that of prescribed for the respective P.G. course (syllabus is available on website of the university).

3. INSTRUCTIONS REGARDING EXAMINATION

- (i) The Examination Centre will open 1 Hour before the commencement of the test.
- (ii) Gates for the examination centre will be closed 30 minutes before the examination, candidates won't be allowed entry in the exam centre after closing of the gate.
- (iii) Candidates must follow instructions of the "Supervisor".
- (iv) If any candidate does not obey instructions and rules, it would be treated as a case of misconduct and adoption of unfair practice and such candidate would be liable for punishment as per rules of the examination.
- (v) Candidates can change the language of the examination paper as required from English to Marathi and vice versa

- (vi) Candidates are required to be present in the examination hall at least 30 minutes before the commencement of the examination.
- (vii) Candidates are expected to assemble at the security check point after the opening of the Examination Centre.
- (viii) The candidates will have to show the issued Admit Card with photograph and Valid Government Photo ID proof which may Include, Aadhaar Card, Driving Licence, Pan Card, Passport, Voter ID card to the Security Officer for admission in the Examination Centre.
- (ix) Candidates who do not possess a valid Admit Card shall not be admitted to the Examination Hall under any circumstances by the Supervisor.
- (x) At any time before or during of examination, the Supervisor can check the Admit Card of the candidates to satisfy himself/herself about the identity.
- (xi) Candidates are required to take their seats as per the roll number shared across on their Hall Ticket. Any candidates found during the test in a seat or room other than the one allotted to them shall have their candidature cancelled.
- (xii) The candidates will undergo initial security check before the commencement of the examination, failing which; they will not be permitted to appear in the Examination.
- (xiii) The candidates are strictly not allowed to carry any items listed below inside the Examination Hall.

The test centre will not have any provision to store, protect or handover any of these items carried by the candidates under any circumstances:

- a. Textual material, printed or written, envelope or any other material except the Admit Card.
 - b. Calculator, Slide Rule, Log Table, Geometry Box, Electronic Digital Watch with calculator, pen, pencil, any device that can write including mobile phone, pager, Bluetooth device, storage device in any form or any other electronic gadget.
 - c. Mobile Phone, Laptop, Digital Tablet & the like.
 - d. Any form of snacks or beverages. Proper drinking facilities will be available inside the examination centre.
 - e. The candidates will not be allowed to leave their seats or the Examination Room/Test Centre until the Test concludes as per schedule. In case of any emergency, candidates may take special permission of the Supervisor on duty who shall report the same to the Observer in writing.
- (xiv) The candidates must submit the test within the allocated time; the test will be auto submitted in case the test is not finished within the allocated time.

- (xv) For candidates who are unable to appear on the scheduled date of test for any reason, re-test or any such request shall not be extended by SantGadge Baba Amravati University, Amravati under any circumstances.

4. TEST PATTERN

- (i) Pattern of the Admission Test: - The PET shall consist of One paper comprising of **Section A** and **Section B** containing 50 objective type questions per Section to be answered on the computer by clicking on the right option.
- (ii) The duration of Online PET shall be 90 minutes, i.e. 45 minutes for each Section A & B. No extra time for whatsoever reason would be allowed to attempt question paper after the stipulated time of 45 minutes for each section is over except for the physically handicapped candidates as per the provisions of concerned Ordinances.
- (iii) Language of Questions, listed options and all instructions will be in English, Marathi and any other language for respective subject as prescribed by SantGadge Baba Amravati University for **Section B**.
- (iv) The valuation of answers will not be made by negative marking system.
- (v) In case candidate does not want to attempt the question he or she should not mouse-click any option. In case he or she has already mouse clicked the option and does not want to give the answer, he or she should click 'Clear Response' against the related question.
- (vi) Candidate will be provided one sheet of Paper & Pencil for Rough work which will be returned at time of exit from Exam hall.

5. UNFAIR PRACTICE & EXAMINATION RULES

Unfair practice means an activity that allows a candidate to gain an unfair advantage over other candidates.

It includes, but is not limited to:

- a) Being in possession of papers, books, notes, electronic devices or any other material or information relevant to the examination concerned listed in General Instruction Sheet.
- b) Someone to take an examination on behalf of the candidate (impersonation);
- c) Breaching examination rules;
- d) Assisting another candidate to engage in malpractice; giving or receiving assistance directly or indirectly of any kind or attempting to do so;
- e) Contacting or communicating or trying to do so with any person, other than the Examination Staff, during the examination time in the examination centre;

- f) Threatening any of the officials connected with the conduct of the examination or threatening any of the candidates;
- g) Using or attempting to use any other undesirable method or means in connection with the examination.
- h) Manipulation & fabrication of online documents viz. admit card.
- i) Forceful entry in Examination Hall with mala fide intentions.
- j) Affixing of fabricated photograph on the admit card.

6. PUNISHMENT FOR USING UNFAIR PRACTICE

If a candidate is found to have indulged in any of the above practices before, during or after the course of examination, the candidate shall be deemed to have used unfair practices at examination and marked as UNFAIR PRACTICE and appropriate action shall be taken against the candidate as per the Section 48 (V) (a) of Maharashtra Public Universities Act, 2016.

7. HOW TO ANSWER THE QUESTION AND SUBMIT TEST?

- i. The candidates will be seated in front of their respective allocated seats fifteen minutes before the test and each candidate will be required to go through the instructions sheet before starting the examination, and for login candidates will be required to fill in their credentials .
- ii. An “Online Instruction page” will be displayed to the candidates on their monitors after login in to the system (A monitor is a visual display for computers.)
- iii. The candidates are advised to read the instructions before the commencement of the test.
- iv. The candidates will be asked to start the test at a given time.
- v. There will be four options to each question and the candidates will be able to click any one option before moving to the next question.
- vi. The candidates can change their options as many times as they want till the end of the examination, however the last selected option will be considered when the candidates submits the test.
- vii. Candidates can choose to skip a question and move to the next question and come back later to respond the un-attempted questions.
- viii. Only on reaching the last question, the “Submit” button will appear on the monitor/screen.

- ix. On Clicking “Submit” button, the candidates will be able to submit the test.
- x. There will be a timer on the candidate’s monitor to apprise the candidate of time left for the completion of the exam.
- xi. The candidates must ensure that they complete the test within the allocated time frame of 45 minutes per SECTION. Otherwise the test will be auto-submitted (It will be submitted automatically by the computer) irrespective of the number of questions being answered by the candidate

8. DISCLAIMERS

- (i) Centre allotment to the candidate shall be made by SantGadge Baba Amravati University on the basis of availability of the number of candidates.
- (ii) In case of any disputes in the interpretation and meaning of the Question, the English version of the question shall be treated as correct and authentic.

9. DISPUTE RESOLUTION

- (i) In case of any dispute, the candidate will have to fill in the requisite “Dispute Form” available at examination centre. The dispute will be verified by the PET Committee and the decision of Honourable Vice Chancellor of the University shall be final and obligatory.

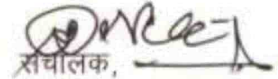

प्रस्तावना:-

राज्यातील सर्व उच्च शिक्षण देणाऱ्या संस्थामध्ये विशेष गरजा असणाऱ्या (दिव्यांग) विद्यार्थ्यांचे अध्ययन, अध्यापन व मुल्यमापनाची पध्दती वेगळी असणे आवश्यक आहे. विशेष गरजा असणाऱ्या (दिव्यांग) विद्यार्थ्यांना शैक्षणिक मुल्यमापनामध्ये गरजेनुसार सोयी सवलती देण्यासंदर्भात घोरण निश्चितीसाठी शासन स्तरावरून समिती गठीत करण्यात आली होती. सदर समितीच्या बैठकीमध्ये सर्व अकृषी विद्यापीठाचे परिक्षा नियंत्रक व दिव्यांगांशी संबंधित असलेल्या विविध संस्थांचे तज्ञ प्रतिनिधी उपस्थित होते. सदरहू बैठकीमध्ये दिव्यांग विद्यार्थ्यांना उच्च शिक्षणामध्ये येणाऱ्या अडचणी व परिक्षा पध्दतीमध्ये त्यांना दिल्या जात असलेल्या व आवश्यक असलेल्या सोयी सुविधांबाबत सविस्तर चर्चा करण्यात आली व त्यानुसार आवश्यक त्या सूचना व अभिप्राय मागविण्यात आले. प्राप्त अभिप्राय व सूचनांचा विचार करून उच्च शिक्षण/विद्यापीठीय शिक्षण घेणाऱ्या दिव्यांग विद्यार्थ्यांना सोयी-सुविधा देण्याबाबतचा शासन निर्णय निर्गमित करण्याचे शासनाच्या विचाराधीन होते. त्यानुसार खाली नमूद केल्याप्रमाणे शासन निर्णय घेत आहे.

And

Whereas, the Management Council in its meeting held on 2-6-2018 vide item No.86 has accepted the afore mentioned G.R.along with the report of committee appointed by Hon'ble Vice-Chancellor and directed to issue direction in this regard.

And

Whereas, the directions No.32/2018 dated 26/6/2018, 43/2018 dated 26/12/2018 and 13/2019 dated 27/6/2019 could not be converted into relative legislation in terms of ordinance in a stipulated period in view of the provision of 12 (8) of Maharashtra Public Universities Act-2016.Hence, these directions are lapsed.

And

Whereas, the Academic Council in its meeting held on 13/1/2020 vide item No.4 has directed "Hereinafter, a fresh Direction shall be issued by superseding earlier Direction if the relative legislation not be made in stipulated period."

And

Whereas, the above said provisions are to be regulated by amending respective ordinances.

And

Whereas, aforesaid provisions are to be implemented from the Academic session 2020-21.

And

Whereas, the making amendments to concerned ordinance is time consuming process,

Now, therefore I, Dr. Murlidhar Chandekar, Vice-Chancellor, Sant Gadge Baba Amravati University, Amravati in exercise of powers conferred upon me under Sub-section (8) of Section 12 of the Maharashtra Public Universities Act-2016 do hereby direct as under-

- 1) This Direction may be called, "**Facilities, exemption and concession for differently abled and Physically disabled examinee of Sant Gadge Baba Amravati University examinations.**"

- 2) This Direction shall come in force with effect from the date of its issuance.
- 3) The following shall be the provisions for providing facilities, exemptions, concession for physically disabled students.
- i) Principal of the respective affiliated college should prepare 'Disabled friends group' of minimum 10 friends out of which disabled students will select one of them who is willing to act as a writer for him/her. He can also select writer of his/her own choice
 - ii) Examination center will be the same college or nearer college to his/her house.
 - iii) Answer Books will be stamped as PWD and the necessary separate arrangements be made for evaluation.
 - iv) Differently abled students of all categories will be given additional 20 minutes per hour beside the stipulated time span.
 - v) Marks should not be deducted for any types of grammatical or technical mistakes at the time of evaluation.
 - vi) Attendance is not mandatory for appearing in the university examinations.
 - vii) All other facilities are applicable as per this direction and guidelines given in the Maharashtra Government Resolution miscellaneous no.2016 No.302 dated 4th of March,2017.
 - viii) This direction provides 3% grace marks of the total marks (aggregate) in one subject for "Head passing written examination, oral/viva, practical, research project etc." or by divisions to the rest of the followings heads.
 - a) Fixed the 3% marks of the total(aggregate).
 - b) Add marks to the subject with least or minimum marks obtained, first and thereafter, second, third, fourth and so on to the subjects in order of lower marks till the 3% of marks.
 - c) If needed, the marks as per the earlier ordinances (1/1985 and 18/2001) shall be awarded to the disabled candidates.
